Participants will explore practical techniques to prevent, detect, and respond to fraud and related risks, enhancing resilience and safeguarding organizational integrity. Through real-world case studies, interactive discussions, and hands-on exercises, Board members and senior management will gain the confidence and tools to address emerging threats with proactive fraud risk management strategies.

They will be prepared to implement governance structures, use critical risk indicators, and apply ISO standards to proactively detect, prevent, and respond to financial crime threats, ultimately strengthening organizational resilience and integrity.

- · Build governance structures and SOPs that enhance fraud and corruption detection, reporting, and response capabilities;
- Foster an ethical culture across the organization with embedded anti-bribery values and a proactive stance on fraud risk management;
- · Implement a secure and transparent whistleblowing mechanism, aligned with ISO 37002, to reinforce accountability and integrity.
